### LIBREOFFICE CELEBRATES 10 YEARS OF THE PROJECT:

28.09.2020

The LibreOffice community has celebrated ten years since its inception. Ten years ago, the leading developers of OpenOffice.org formed a new nonprofit organization, The Document Foundation, to continue the development of the office suite as a project independent of Oracle, not requiring developers to transfer property rights to the code and making decisions based on the principles of meritocracy.

The project was created a year after the takeover of Sun Microsystems due to dissatisfaction with the tight control of development by Oracle, which prevented interested companies from connecting to collaboration.

**DSL (DOS SUBSYSTEM FOR** LINUX) PROJECT FOR **RUNNING LINUX** APPLICATIONS FROM MS-**DOS** ENVIRONMENT: 09/28/2020

harlie Somerville, who develops the CrabOS operating system in Rust as a hobby, presented a comic, but quite working draft DOS Subsystem for Linux (DSL). It is positioned as an alternative to the WSL (Windows Subsystem for Linux) subsystem developed by Microsoft for those who prefer to work in DOS. Like WSL, the DSL subsystem allows you to directly launch Linux applications, not from Windows, but from the MS-DOS or FreeDOS command shell. The subsystem sources are distributed under the AGPLv3 license.

A DOS environment with a DSL layer can be run in the form of a QEMU virtual machine, or installed on real hardware. Linux programs are launched using the dsl utility, similar to the wsl utility.

buntu GamePack 20.04 is available for download, which includes tools for running more than 85 thousand games and applications, both specially developed for the GNU / Linux platform, and games for Windows launched with PlayOnLinux, CrossOver and Wine, as well as older games for MS-DOS and games for various game consoles (Sega, Nintendo, PSP, Sony PlayStation, ZX Spectrum).

The distribution kit is built on Ubuntu 20.04 and includes all updates, as of September 2020.

### MIR DISPLAY SERVER 2.1 **RELEASED:**

09/29/2020

The release of the display server Mir 2.1 is out, the development is continued by Canonical, despite the abandonment of the development of the Unity shell and the Ubuntu edition for smartphones. Mir remains in





demand in Canonical projects and is now positioned as a solution for embedded devices and the Internet of Things (IoT). Mir can be used as a composite server for Wayland, which allows any application that uses Wayland (for example, built with GTK3 / 4, Qt5, or SDL2) to run in Mir-based environments. Installation packages are prepared for Ubuntu 18.04-20.10 (PPA) and Fedora 30/31/32. The project code is distributed under the GPLv2 license.

### SCUMMVM 2.2.0 IS OUT: 09/29/2020

The release of the free crossplatform interpreter of classic games, ScummVM 2.2.0 was released, which replaces executable files for games and allows many classic games to run on platforms for which they were not originally intended. The project code is distributed under the GPLv2 license.

In total, it is possible to launch more than 250 quest games and

about 1600 interactive text games, including games from LucasArts, Humongous Entertainment, Revolution Software, Cyan and Sierra, such as Maniac Mansion, Monkey Island, Broken Sword, Myst, Blade Runner, King's Quest 1-7, Space Quest 1-6, Discworld, Simon the Sorcerer, Beneath A Steel Sky, Lure of the Temptress, and The Legend of Kyrandia.

### **OBS STUDIO 26.0 VIDEO** STREAMING SYSTEM RELEASED:

BS Studio 26.0 for streaming, streaming, compositing and video recording is out. The code is written in C / C++ and is distributed under the GPLv2 license. Binaries are generated for Linux, Windows and macOS.

The development goal of OBS Studio is to create a free version of the Open Broadcaster Software application, not tied to the Windows platform, supporting OpenGL and extensible via plugins.

### **XEN HYPERVISOR SUPPORTS** RASPBERRY PI 4 BOARD:

30.09.2020

The developers of the Xen project announced the implementation of the possibility of using the Xen Hypervisor on Raspberry Pi 4 boards. Adapting Xen to work on previous versions of Raspberry Pi boards was hampered by the use of a nonstandard interrupt controller that does not have support for virtualization. The Raspberry Pi 4 used the usual GIC-400 interrupt controller supported in Xen, and the developers expected that there would be no problems starting Xen. But in reality, everything turned out not to be as expected, and in order to make Xen work on the Raspberry Pi 4, noticeable changes had to be made to the code to work with memory. The fixes were included in the Linux 5.9 kernel, and now Xen is recognized as ready for virtualization on Raspberry Pi 4 boards.

### **PALE MOON 28.14 BROWSER RELEASED:**

30.09.2020

The Pale Moon 28.14 web browser has been released, a fork of the Firefox codebase to provide better work efficiency, preserve the classic interface,





minimize memory consumption and provide additional customization options. Pale Moon binaries are built for Windows and Linux (x86 and x86 64). The project code is distributed under the MPLv2 (Mozilla Public License) license.

The project adheres to the classic organization of the interface, without switching to the Australis interface integrated into Firefox 29, and providing ample customization options. Remote components include DRM, Social API, WebRTC, PDF viewer, Crash Reporter, code for collecting statistics, parental controls and people with disabilities. Compared to Firefox, the browser retains support for XUL technology and retains the ability to use both fullfledged and lightweight themes.

### **OPENCL 3.0 FINAL SPECIFICATIONS PUBLISHED:** 09/30/2020

hronos, which is responsible for the development of

specifications for the OpenGL family, Vulkan and OpenCL, announced the publication of the final specifications for OpenCL 3.0, defining APIs and extensions of the C language for organizing crossplatform parallel computing using multi-core CPUs, GPUs, FPGAs, DSPs and other specialized chips. From those used in supercomputers and cloud servers to chips that can be found in mobile devices and embedded technology. The OpenCL standard is completely open and does not require royalties.

At the same time, an open source OpenCL SDK with tools, examples, documentation, header files, bindings for C++ and C libraries for developing applications compatible with OpenCL 3.0 was published.

### FEDORA LINUX EDITION FOR **SMARTPHONES INTRODUCED:**

02.10.2020

A fter ten years of inactivity, the Fedora Mobility team is back on track to develop an official edition of the Fedora mobile distribution. Fedora Mobility is designed to be installed on the PinePhone smartphone developed by the Pine64 community. Future editions of Fedora and other smartphones, such as the Librem 5 and OnePlus 5 / 5T, are expected to emerge with support in the stock Linux kernel.

Currently, a set of mobile packages has been added to the Fedora 33 (rawhide) repository, which includes a touch-controlled custom Phosh shell. The Phosh shell is developed by Purism for the Librem 5 smartphone, uses the Phoc composite server running on top of Wayland, and is based on GNOME technologies (GTK, GSettings, DBus).

### THE FREE SOFTWARE FOUNDATION TURNS 35:

10/05/2020

The Free Software Foundation is celebrating its 35th anniversary. The celebration will take place in the form of an online event, which is scheduled for October 9. Among the ways to celebrate the anniversary, it is also suggested to experiment with installing one of the completely free GNU / Linux distributions, try to master GNU Emacs, switch to free versions of proprietary software, participate in promoting freejs, or switch to using the F-Droid directory of Android applications.

In 1985, a year after the GNU Project was founded, Richard Stallman founded the Free Software Foundation. The organization was formed to defend against dubious companies caught in the misappropriation of code and trying to sell some of the first GNU Project tools developed by Stallman and his associates. Three years later, Stallman drafted the first version of the GPL license, which defined the legal framework for the free software distribution model. On September 17 last year, Stallman stepped down as president of the Free Software Foundation, and Jeffrey Knuth was elected two months ago.

buntu RescuePack is available for download, designed to detect malware and cure infected computers. Includes antivirus packages of ESET NOD32 4,





BitDefender, COMODO, eScan, F-PROT and ClamAV (ClamTk). The distro is also equipped with tools for recovering deleted files. The size of the bootable Live image is 2.6 GB.

The disk runs, without launching the main operating system installed on the computer (MS Windows, macOS, Linux, Android, etc.), to conduct a full anti-virus scan to detect and remove viruses, Trojans, rootkits, worms, spyware and ransomware in the system. The use of an external disk prevents malware from interfering with the neutralization and restoration of the infected system. Data validation is supported in FAT, FAT32, exFAT, NTFS, HFS, HFS +, btrfs, e2fs, ext2, ext3, ext4, jfs, nilfs, reiserfs, reiser4, xfs and zfs file systems.

### RELEASE OF THE EPHEMERAL 7 BROWSER, DEVELOPED BY **ELEMENTARY OS:**

06.10.2020

The release of the Ephemeral 7 web browser, developed by the elementary OS development team specifically for this Linux distribution, has been published. For development, the Vala language, GTK3 + and the WebKitGTK engine were used (the project is not a branch of Epiphany ). The code is distributed under the GPLv3 license. Readymade binaries are made only for elementary OS (the recommended price is \$ 9, but you can choose an arbitrary amount, including 0). The browser can be compiled from the source code for other distributions as well.

ed Hat has released Red Hat Enterprise Linux 7.9 (the new version was announced a week ago only on the access.redhat.com portal, the announcement did not appear on the mailing list or in the press release section). RHEL 7.9 installation images are available for download by registered Red Hat Customer Portal users only and are prepared for x86 64, IBM POWER7 +, POWER8 (big endian and little endian), and IBM System z architectures. The package sources can be downloaded from the CentOS project Git repository.

The RHEL 7.x branch is being maintained in parallel with the

RHEL 8.x branch and will be supported until June 2024. The first phase of support for the RHEL 7.x branch, which includes functional improvements, is complete. The release of RHEL 7.9 follows the transition to the maintenance phase, in which the priorities have shifted towards bug fixes and security, with minor improvements related to supporting critical hardware systems.

Usually, during online conferences, only one participant is allowed to speak, and simultaneous discussions are problematic. In Calla, to organize natural communication, in which

The main feature is a three-pane interface where you can create playlists from catalogs and switch between playlists. During playback, the audio codecs installed in the OS are used (connected via QtMultimedia). The code is written in C++ using the Qt library and is distributed under the GPLv3 license. Binaries are prepared for Windows and Linux distributions of openSUSE, Debian, Fedora, Ubuntu, CentOS and Mageia. Features include the ability to use Internet radio with playlists in m3u and pls formats, CUE support, the ability to remotely control the player using the MPRIS protocol, log playback, settings in yaml format.

## REDO RESCUE 2.0.6 RELEASE, BACKUP AND RECOVERY DISTRIBUTION:

11.10.2020

The Live-distribution, Redo Rescue 2.0.6 , designed to create backups and restore the system in case of failure or data corruption, is out. State slices created by the distribution can be fully or selectively cloned to a new disk (creating a new partition table) or used to restore system integrity after malware activity, hardware failures, or accidental data deletion. The distribution uses the Debian codebase and partclone toolkit from the Clonezilla project. Redo Rescue's own work is distributed under the GPLv3 license. The size of the iso image is 410MB.

Backups can be saved both to locally attached media (USD Flash, CD / DVD, disks), and to external partitions, which are accessed via NFS, SSH, FTP or Samba / CIFS (an automatic search for shared sections). It supports remote management of backup and restore using VNC or web interface.

### ONLYOFFICE 6.0 RELEASED:

new release of the OnlyOffice 6.0 suite is available, designed for working with text documents, spreadsheets and presentations. The editors are desktop applications that are written in JavaScript using web technologies, but combine client and server components in one set, designed for self contained use on the user's local system, without accessing an external service. The project code is distributed under the free license AGPLv3.

OnlyOffice claims full compatibility with MS Office and OpenDocument formats. Supported formats: DOC, DOCX, ODT, RTF, TXT, PDF, HTML, EPUB, XPS, DjVu, XLS, XLSX, ODS, CSV, PPT, PPTX, ODP. Functionality of the editors can be expanded through plugins, for example, plugins are available for creating templates and adding videos from YouTube. Binaries for Windows. macOS and Linux (deb- and rpmpackages, packages in Snap, Flatpak and AppImage formats will also be generated in the near future).

At the same time, a new release of OnlyOffice DocumentServer 6.0 was announced with the implementation of a server for working with OnlyOffice online editors from a web browser for collaboration. You can also use the Nextcloud Hub platform for collaboration at your facilities, which provides full integration with OnlyOffice.

## Jami Decentralized Communication Client Released:

20.10.2020

The first release of the Jami decentralized communications platform, codenamed "Together", was announced. Jami is one of the GNU projects and was previously developed under the name Ring (previously SFLphone), but was renamed in 2018 to avoid trademark infringement. The code is distributed under the GPLv3 license. Binaries are prepared for





GNU / Linux (Debian, Ubuntu, Fedora, SUSE, RHEL, etc.), Windows, macOS, iOS, Android and Android TV. Several options for interfaces based on Qt, GTK and Electron are being developed. Unlike traditional communication clients. Jami is able to transfer messages without contacting external servers through establishing a direct connection between users using end-to-end encryption (end-to-end, keys are present only on the client side) and authentication based on X.509 certificates. In addition to secure messaging, the program allows you to make voice and video calls, create teleconferences, exchange files, organize shared access to files and screen content.

## GIT 2.29 DISTRIBUTED SOURCE MANAGEMENT RELEASED:

20.10.2020

The Git 2.29.0 is now available. Git is one of the most popular, reliable, and high-performance

version control systems, providing flexible non-linear development tools based on branching and merging. To ensure the integrity of history and resistance to changes "retroactively", implicit hashing of the entire previous history in each commit is used, it is also possible to certify with digital signatures of the developers of individual tags and commits. Compared to the previous release, 627 changes were adopted in the new version, prepared with the participation of 89 developers, of which 24 took part in the development for the first time.

ritHub has blocked the Tepository and all mirrors of the youtube-dl project, which is developing a command line utility for downloading videos from YouTube and other sites. It was blocked under the US Digital Millennium Copyright Act (DMCA) following a complaint from the Recording Industry Association of America (RIAA).

The claims boil down to the presence in the repository of code with examples of downloading licensed content from YouTube. In particular, in the code of scripts for extracting video, there is a section with tests of correctness of work, in which links to materials whose copyright belongs to RIAA participants are indicated as examples to be checked. Tests are also used to verify that the age restriction and encrypted content download (cipher signature) bypass is working, and these bypass targets are explicitly indicated in the test notes.

The new version received 16074 fixes from 2011 developers, the size of the patch is 62 MB (the changes affected 14,548 files, 782,155 lines of code added, 314,792 lines removed). About 45% of all changes introduced in 5.9 are related to device drivers, approximately 15% of changes are related to updating code specific to hardware architectures, 13% are related to the network stack, 3% are related to filesystems and 3% are related to internal kernel subsystems.

The free office suite
OpenOffice.org turns 20 - on

October 13, 2000, Sun Microsystems released the source code for the office suite StarOffice, which was created in the early 90s by Star Division, under a free license. In 1999, Star Division was taken over by Sun Microsystems, which took one of the most important steps in open source history — making StarOffice a free project. In 2010, Oracle got its hands on OpenOffice along with other Sun Microsystems projects, but after a year of trying to develop OpenOffice.org in-house, it handed the project over to the Apache Foundation. The last patch release of Apache OpenOffice 4.1.7 was a year ago, and there have been no major releases in 6 years. The initiative to develop a free office suite was intercepted by the LibreOffice project, which was created in 2010 due to dissatisfaction with Oracle's tight control over OpenOffice.org development, which prevents interested companies from connecting to collaborative work.

LibreOffice developers
published an open letter in which
they called on the Apache
OpenOffice developers to work
together, since Apache OpenOffice
has long been in deep stagnation,

and all development in recent years has been concentrated in LibreOffice. Compared to OpenOffice, LibreOffice has such features as export in OOXML (.docx, .xlsx) and EPUB formats, digitally signed documents, significant Calc performance optimizations, a redesigned NotebookBar interface, Pivot Charts, watermarks, and secure mode (Safe Mode).

Despite stagnation and a virtual lack of support, the OpenOffice brand remains strong with downloads still in the millions and many users are unaware of LibreOffice. The LibreOffice developers have invited the OpenOffice project to inform its users about the existence of an actively maintained and more functional product that continues the development of OpenOffice and includes new features that modern users need.

Sequoia 0.20.0, which offers a library of functions and command line tools that implement the OpenPGP standards (RFC-4880), is out. Sequoia is being developed by three members of the GnuPG project, who decided to create a new free implementation of OpenPGP in the Rust language to improve the security and reliability of the code base, which provides tools for safe working with memory. In addition to improving security, Sequoia is also trying to fix the flaws in GnuPG, which cannot be fixed in the main project without breaking compatibility or significantly reworking the code base. For example, GnuPG has a fairly tight relationship between components that makes it difficult to make changes, obfuscates the codebase, and prevents the creation of a complete unit testing system. The gpupg command line toolkit is not synchronized in functionality with the function library and some actions can only be performed using the utility itself.



**Demystifying Nmap Pt.1**

Blurb: "Nmap ("Network Mapper") is a free and open source (license) utility for network discovery and security auditing. Many systems and network administrators also find it useful for tasks such as network inventory, managing service upgrade schedules, and monitoring host or service uptime. Nmap uses raw IP packets in novel ways to determine what hosts are available on the network, what services (application name and version) those hosts are offering, what operating systems (and OS versions) they are running. what type of packet filters/firewalls are in use, and dozens of other characteristics. It was designed to rapidly scan large networks, but works fine against single hosts. Nmap runs on all major computer operating systems, and official binary packages are available for Linux, Windows and Mac OS X. In addition to the classic command-line Nmap executable, the Nmap suite includes an advanced GUI and results viewer (Zenmap), a flexible data transfer, redirection, and debugging tool (Ncat), a utility for

comparing scan results (Ndiff), and a packet generation and response analysis tool (Nping)."

Map is a tool I find very handyunmissable, but people often say it is difficult to use. For those people, there is Zenmap. The command-line nmap has a bit of a learning curve, but once you understand it, it is really great.

I sometimes have to get my bearings on a network before

working. The more you know, the better your diagnostics will be. However, some clients have shifted to this global IT nonsense, where you cannot do anything on the network without first creating a ticket, waiting three days and supplying blood and stool samples for each thing you want to do. If you do not, the IDS and firewall will shut you down. On top of that the global IT gets it wrong anyway, as they have phone monkeys on the other end and not real IT people.

This is where nmap shines. We can look at how to use nmap, how to sneak past IDS and defeat firewalls.

Let me scare some of you – type nmap in your terminal and just press enter. Look at all the options and read what it says. The rest of you say: "Challenge Accepted!" with me. It goes without saying, that you will be scanning your own home network and not fbi.gov.

Before we talk about nmap's options, I want you to head over to this website and read what a three-way handshake is: <a href="https://www.geeksforgeeks.org/tcp-3-way-andshake-process/">https://www.geeksforgeeks.org/tcp-3-way-andshake-process/</a> - The better that you know the underlying process, the easier you will pick up nmap. Feel free to read all the sections down the side of that page.

Now, nmap is known as a port scanner, but it is more than that. Most of the time, I simply use it to scan for live hosts and pipe the output to a text file. Security researchers and penetration

testers will use it in another way. The most common "port scan" I use is port 53 -DNS. Here is a list of common ports:

https://www.iana.org/assignments/ service-names-port-numbers/ service-names-port-numbers.xhtml

or:

https://en.wikipedia.org/wiki/ List of TCP and UDP port numb ers

Why am I telling you to look at port numbers? Well, with nmap, you may just want to scan for a specific port, say SSH on port 22, or the lazy admin obfuscation port 2222. Also 'port' is easy to remember as it is -p. Thus nmap -p 22 192.168.0.0/24 will scan for that port only on my network. By contrast, scan your same network without that "-p 22" and see how much longer it takes. You can also scan a range of ports, simply by specifying the start and end port. Like so: "-p 22-53". By default nmap only scans the 1000 most common ports, so if you would need to scan them all, you would use the "-p-" switch before the host IP. It is a good idea to do this against your IOT devices, to see what is open

(that should not be). This is a long scan, so it is best to do it against one IP at a time. Speaking of time, there is a time option in nmap too. You use the "-T" switch to set the time to wait for a response. However, the range is from 0-5, zero to five, five waits the least time (5ms) for an answer. In other words, 0 waits almost indefinitely, just kidding, but it feels that way. Most of the time I use T4 (recommended by nmap themselves) and usually skip the others. Feel free to try them too. To pipe your output to a file, simply add the redirector and the name of your file to the end of your query. (Example: nmap -p 22 192.168.1.1 > router.txt).

This article is pretty much hands on, you need to open a terminal and scan your network, router, or another live PC on your network.

By now you have tried:

nmap

nmap -p 22 <your IP range
here>

nmap -p 22-53 <your IP range
here>

nmap -T5 <your single IP
address here>

nmap -T4 <your single IP
address here>

nmap -p- <your single IP


There is another "time" you need to know about and that is the Round Trip Time (RTT). This is the time it takes your packets to make a round trip. To know what this is, simply ping any website. The first value is TTL (Time To Live); if you are unsure what that is, it is the time in seconds, given to the data, to live, so it doesn't bounce around the network forever and ever. The next value you get is a time in milliseconds; that is what you are after. You are able to set this time too, extending the time you wait

for your packet to return. You use the rtt-timeout switch, but you need a prefix. For now I will cover only the "initial" timeout.

Therefore, the switch is: --initial-rtt-timeout (two dashes at the beginning), and you need to give the value in milliseconds. Example: nmap --initial-rtt-timeout 200ms canonical.com You can also set the maximum timeout, but we will cover that later.

Let's use the five whys:

- Why would we use nmap in the first place?
- You need to reconnoitre the network.
- Why would we need to reconnoitre the network?
- We need to make informed problem determinations.
- Why do we need to make informed problem determinations?

 We can guess as to what the problem is, but it is always better to be sure. Sometimes one error can be very similar to another and some equipment can behave erratically and flood your network.

#### • Why do we make sure?

• Problems with networks can do many things; if a client cannot access their website, it could be anything from DNS to a network loop. Time is money and the sooner it is taken care of, the sooner business can resume.

#### • Why are there so many vectors?

• That's why we have nmap!







### Python In The REAL World Pt.110

ast month, a PAGE user came to both Don and myself for some help with a fairly new Python library that implements a spreadsheet like table widget written completely in Python. He was fairly new to PAGE and was having trouble getting the table to initialize properly. I thought the library has a tremendous amount of possibilities, so I thought I'd share the information with you. Just so you know, you don't have to use PAGE to implement the sheet widget, but you do have to use Tkinter at least.

To get started, you need to install the library and, as usual, we can use Pip to do it.

#### \$ pip install tksheet

Once you've done that, you might want to consider downloading the entire source code from the github repository at <a href="https://github.com/ragardner/tksheet">https://github.com/ragardner/tksheet</a>. I suggest this since there are so many options that this library has, you might not catch some without digging into the

source code. The documentation for the library is currently being written, so it's easy to suss out how to do some of the options by having the code available.

We'll use a modified version of the demo program to start with, which does not require PAGE. You can find the full version on the homepage of the repository.

As almost always, we want to import the important libraries, in this case, the tksheet and tkinter libraries.

Now (top right) we'll create a class called demo. This will hold all of the code for the demo program that deals with the sheet widget. As you go through the code, you

will see that many of the functions later on are simply there to allow you to customize the builtin functions that the library has.

As you already know, the \_\_init\_\_ function sets up various parameters and defaults. In the next lines, the sheet object is simply an instance of Sheet (above).

Here (below) is where you load the dummy data into the sheet.

Next (next page. top right), we enable the various bindings that are already coded in the library.

The next two lines insert the frame and sheet objects into a Tkinter grid.

As you can tell from the commented code (bottom right), the next set of lines show ways to control various things like the theme, highlighting columns, rows and cells, etc.

The rest of the code (next page, right side) overrides the default events and bindings, and provides examples of how to handle them in your own code.

Finally, the required instantiation of the demo class object and the call to the Tkinter mainloop.

When you fire up the program, you should see something that looks like the image on the next page (top right).

While that wasn't too hard at all, I believe that using PAGE makes the process much easier. I've created a VERY simple PAGE GUI to show how quickly and easy it is.




project and start up PAGE within that folder. Expand the default Top level form just a bit and place two buttons near the very top of the form, one on the left and one on the right. The left one should have the text "Load CSV", and the one on the right "Exit". In the command attribute for the left button enter "on btnLoad" and for the right button "on btnExit". (We've covered PAGE programming so often, this should be very obvious, but if it isn't, look at one of my previous articles about using PAGE. My article in FCM#155 should be a good easy reference).

Next, place a frame in the form that takes up pretty much of the rest of the form. Then place a custom widget into that frame and expand it to fill the frame. (Mouse-3 (Right-click for most people)) | Widget | Fill Container). Save your project as tksheetGUI.tcl and generate your python code.

Bottom right is what your project hopefully looks like. If not, that's ok. You get the general idea.

Now open tksheet\_support.py in your IDE or editor, and let's get to work.

PAGE only creates a single import line, since that's all that you need to get started. Add the following lines to the import section of the code to support our needs. The line that PAGE gives us is not in bold.

We also need to modify the import section that PAGE provides for us. Normally, you would not need to do this, but we are going to add support for the Tkinter messagebox and the filedialog subsystems.

Note that we actually don't do anything with the messagebox but it's there for your possible future development.

Now (top right) we need to add a couple of lines to the init function, that again, PAGE provides for us.

As I'm sure you are aware, this (middle right) will call the startup() and init custom() functions before the form is shown to the user. Let's look at the startup function first.

Yes, there is some code that isn't strictly needed, but I like to add it. Basically, we get and provide the python version, program path and program version, and print all of that to the terminal window. Then we set up some global default values for use with the tksheet library.

In the init custom() function, we will be initializing various settings of the tksheet for our use.

It took me a fair amount of time to narrow down the actual settings needed for proper demo use. There are many other settings as you saw in the earlier demo program, but, for us, these are needed. One thing to note is the

theme setting (see below). There are four default themes defined by default. The first demo used the light green theme. For the PAGE version, we will use the dark blue theme.

Now (top right) we need to enable the bindings that we want so that the functionality is what you would normally expect for a spreadsheet demo. These are things like selecting a single cell, a row or column and using the arrow keys as well as allowing for "right-click" (mouse 3) context menu support.

The next few lines (bottom right) allow you to use the popup context menu. Some of them are pretty obvious, but it's not as clear why the last 6 lines would be needed.

The last part of the init\_custom function (bottom right) deals with binding the Mouse-3 button to the "rc" routine and sets extra bindings for us to be able to override the default functions within the library.

Now (next page, top right) we'll create the four callback functions that we just defined. I must admit that I created the first three for a different demo that printed the information to a status label, but I felt that, for this very simple demo, printing to the terminal was ok.

I created a simple class to handle the actual tksheet as a

custom control. See next page, bottom right.

Almost at the end now. We still have to assign the library as the custom control. PAGE supplies a line that says "Custom = tk.Frame", but we need to replace tk.Frame with our external tkinter control library. You can add the following

line and comment out the 'Custom = tk.Frame' line.

Custom = sheet



Finally, we need to provide the callback and support functions for the buttons that we defined when we designed the GUI (next page, top right). PAGE generated the first two functions for us as skeletons. The final function helps the import of the CSV files. You already have seen the proper way to end a PAGE application, but I've included it here for your convenience.

Now (next page, middle) we have the callback for the load csv file button. It's a little bloated, but I thought it would be easier for you to follow the code this way rather than write it more elegantly.

Last but not least, here (bottom right) is the load\_csv\_file function. Here we are using pandas to read the CSV file and convert it into a list. That way, the tksheet library can utilize it.

Be sure to save your file.

Last but not least (again!), you need to know where a good CSV file is. For this demo, I have used the titanic3.csv file which is provided with the source code for the Pandastable Library. I'm certain it's been released into the public domain. I copied it and put it into

the development folder for quick access.

Once you run the program, it should look something like this:

I hope that you enjoyed this month's project as much as I did creating it. This library has a lot of potential and will be great for quick display of things in table or sheet format. However, there is no code to write back to a file (that's simple enough for you to work out) and there are no calculation functions at this point. But this is a fantastic library and something that has been needed for a very long time!

### Podcast Production in Linux - Pt.4

So this month we will cover how to create your RSS feed, to push your audio directly to the podcatchers of those people who subscribe to the feed to receive updates as you publish new content.

First, a warning about setting up the feed for your audio. Although the audio is going to be hosted elsewhere (and not actually on the Blog servers), you are limited to a grand total of 1MB of data (yes, less than an old 3.5" floppy's amount of data) for each post being fed via feedburner. If you go over this, the post will not get fed to people subscribed to the feed; it is easy to breach the 1MB limit even with just a long set of show notes without any pictures. This caused me endless frustration when I started to publish the Distrohoppers Digest pages. I was trying to push the feed without success – until, after quite a bit of Googling, I was able to find out what the problem was. As a result, I now publish the show notes as a separate page, with a link after the first paragraph to ....'more' on the

actual Blog post. This allows more text and images if needed, and as this is not on the feed, the page size should be well under the 1MB limit, allowing the feed to be processed.


OK, let's look at setting up your Feed. First, you will need a link to where your audio is stored, either on your self-hosted server, or to the audio stored on archive.org as we do with Distrohoppers and mintCast. If using archive.org, you may want to consider a small monthly donation to them to offset some of their hosting costs; while it is not compulsory to do this, if you are donating 1£/2\$ per month, this is 12£/\$24 per year, and that is good value for hosting; other service providers start at around \$5/ month, \$60/year. Setting up an account with archive.org is as simple as providing an email address and password, and, if using it for podcast hosting, you can use the email created for the Blogger account. We will look at this further in a future article.

So, to be able to publish the

feed, you need to link your Blog to Feedburner, so navigate to feedburner.com from your google account and you should come to this page. As you can see, there are already a number of feeds in the list for my blogs, but we want to create one for our 'Test Blog' which has the address of 'testtonyh1212.blogspot.com'. To create a feed address for this blog, we need to create a new feed. Under the list is the message:

"Burn a feed right this instant. Type your blog or feed address here:"


in the box below this, put in the blog's web address and tick the box that says 'I am a podcaster'.



Click next, and you will see this box with the options to make an atom or RSS feed, check the RSS feed.




Then click next, and you should have successfully created your feed address which will be showing in the box on the screen.







### **HOWTO - PODCAST PRODUCTION**




If you wish, you can just skip straight to managing the feed. At this point, while you are here, you might as well set up the finer points of the feed such as how iTunes will see the feed and key words to assist people finding your content. The picture shown right shows this process in one image including now being able to see the feed on your Feedburner home screen; Test is now the Second Blog listed.

So you now have feedburner set up with an RSS address that you will use later to set up the feed on your Blog. In my case the test Blog feed reads like this: <a href="http://">http://</a>
feeds.feedburner.com/blogspot/

PSYbSL, with the end PSYbSL being the unique identifier for the feed. It is this full http://feeds... address that we will be using when we create the Feed 'Gadget' for your Blog's home page, so our next step is to navigate to our Blogger account and start setting up the feed.

On the left-hand of your Blogger page will be the menu with all the options to create a new post, etc; navigate to the 'Layout' and open this; you will be presented with something like this (shown above), you may need to scroll down a little to see the right-hand sidebar.



Click on the 'Add a Gadget' and this screen (shown right) opens.

Again you may need to scroll down to see the 'Feed' section. Click the '+' to open the dialogue box to add your feed details. The following picture is a compilation of following the screens to create the Gadget. After putting in the Feedburner address we created earlier, we then put in our title for the feed and preference for the number of posts that will be seen by pod-catchers, the maximum being five. Save this and the Gadget now shows in the Layout; if you now navigate to the Blog home page, you should see the title you gave the feed next to RSS.

So now anyone with the feed URL that you put into the Gadget will be able to subscribe to that in their pod-catcher, and every time you create a new Blog with audio linked in it, they will have that audio or a link to it pushed to their pod-catcher.

Next time, I will go through uploading your audio to archive.org and then linking this in your blog post each time you record a new episode.

### Rawtherapee - Pt8

To take a photo, the ideal is for the light to be behind you. We know that this is not always possible: taking a picture of your dog, when he is being adorable, but with the sun behind him, or your friends goofing around at sunset or sunrise. We have all been there. That photo may not be a total waste after all.

In a recent discussion on blackand-white photography, the discussion on applications, like Snapseed's (- not picking on Snapseed, it is just the most wellknown in our circle) ability, or inability, to make black-and-white photos look real, came up.

Just taking the color away from a photo does not make a nice black-and-white photo. Doubly so when you have applied post-processing to it. Too often, we see people posting pictures in forums where the edges are darker than the body.

How do these two topics fit together, you may ask? The answer is Rawtherapee.

When you have a photograph

where the sun is somehow shining into your lens, be it behind a cloud or peeking over a rooftop, it is not always the easiest to recover. This can be compounded when you took the picture in jpeg-format. In this issue, we want to tackle a photograph like that. Just to go from bad to worse, I will be using a jpeg instead of a RAW image.

This (bottom left) is what we will be working with. As you can see, the sun decided to peek out from behind the cloud as I tried to take a picture of the corpuscular rays. Since there is nothing of

interest in the photograph, I would usually just send it straight to the bin. Let's assume there was something in the image that I wanted. If we look at our histogram, you will see that black is actually squashed up to the edge as well as white.

If I turn on clipping, you can see the problem immediately. Hectic loss of detail. (See the right-hand side and the bottom of the photograph.)

Turning this image into blackand-white should lessen the loss of

detail. Alt+C, or clicking the third icon, will bring up the color menu. Find black-and-white, the fourth sub-menu and turn it on. This does not remove the loss of detail we can see with the clipping filters on, but it puts it into the realm of absolutes of light and shadow. Now we have a black-and-white picture that is still boring, but the loss of detail had become deep shadows.

The next tool we are going to use is "local contrast". This falls under detail, so Alt+D or click the second icon.

A word of warning though, improper use of the local contrast can make your black-and-white photograph look extremely "shopped".

The key here is the first two sliders, radius and amount. The larger the radius, the more feathering you will get from the edges. However, radius alone does nothing. This is where the amount slider comes in. If you are in the artistic mood, slide both the radius and amount to maximum. This will bring some drama to the photo, unless you have uniform dark areas that are not black. If you have those, it will look like a kid took a marker to the edges of the picture, before coloring it in with a lighter color. I actually encourage you to do this, then play with lightness level and darkness level to acquire the desired effect. Just keep an

eye on your histogram, as we already have clipping that we are trying to hide. You do not want to compound your problems.

Drama!!

But let's assume you want clarity, rather than drama? We need to increase our zoom to 100%.


Tip: don't fret over details in the photo that are going to be cut in the end. By this I mean, if you are planning to crop your picture and you were going to cut off the left hand side, don't worry about how your edit affects the object on the left. It is going to end up on the cutting room floor, so to speak.


At 100%, I can zoom into the roof at the bottom and show you the difference between a radius of 20 (minimum) and a radius of 80. This is what you have to look out for when you use local contrast on a picture.

Compare these two images (below)

Pay attention to the amount of visible tiles on the roof, from the edge. When using this effect on color photos, you may see a light discoloration on the side of the light, and dark discoloration on the side where it is dark. This is one very quick way to tell if a photo has been put through a filter. This is

also the difference between editing by hand and using an application like Snapseed. Once your eye is trained to this, it is very hard to "unsee". You will see this in some so-called "professional" photographs on the web, or even magazines. A good rule of thumb is that, when you see the dark edges start to appear, you can either decrease the radius and/or decrease the lightness, to "smooth things out".

I urge you to take a few photos and play with only this effect. It does not have to be black-andwhite. That part was just to show you that you can save boring photographs or even a clipped one, by making it black-and-white, where that clipping does not matter as much any more.

**Tip**: Turn the effect on and off while being zoomed in, as well as being zoomed out.

Local contrast is for sharpening; you do not want to add rifts or halos to your image.

Once you are done, crop your image with the "C" key and you are good to go.

I hope you had fun if you followed along and I hope you learned something.



## Inkscape - Part 102

As you may have noticed in the News section of the previous edition of FCM, a new minor release of Inkscape is out. As is often the case with these things, the announcement came only a couple of days after the deadline for my previous article. As it turns out, version 1.0.1 doesn't fix any of the issues I've raised in recent months, or change any of the features that I've described. Phew! No corrections required.

So what is new in the latest release? It's mostly bug fixes and stability improvements, though there is a whole new "Selectors and CSS" dialog that is most likely to be of interest to web developers. I'll cover it in due course, but it's not the topic for this month's instalment. Instead, I'll cover some changes to the 'Path > Stroke to Path' function. To better understand this menu entry, however, I'm going to start with its sibling.

'Path > Object to Path' is a mainstay of any experienced Inkscape user. As the name suggests, it converts your object to a path, and is therefore commonly used when you want to break out of the design shackles imposed by an object's native type. Whilst a rectangle can have only its width, height and corner radius modified, converting it into a path lets you move individual nodes, add more, or delete others. Since paths are so flexible, it can open up a world of design possibilities – albeit at the expense of losing access to the specialized editing tools for the original object type.

There's nothing controversial about Object to Path. The end result maintains its fill and stroke properties, so there's no visual change as a result of the operation. All that's happened is that your native Inkscape object becomes a generic path of the same size, shape and appearance.


Despite the similar name, however, Path > Stroke to Path is an entirely different beast. At its core it converts any stroke that you may have on your object into a new filled path which matches the stroke's original outline. If it sounds confusing, perhaps some examples will help. Let's start with the simplest example possible: a straight line.



The top line is our original path, consisting of two nodes, no fill, and a thick, red stroke. As a rule it's easiest to understand what Inkscape is doing when applied to thick strokes, but everything I describe can also be done with thinner strokes if that suits your requirements.

The bottom line is the result of the Stroke to Path operation. You can see that what we now have is a filled path consisting of four nodes arranged to match the original stroke's outline. The fact that it's a filled path is a really important point to grasp: the original shape had a stroke but no fill, whereas the new shape has a fill but no stroke. The fill color of the new shape is the same as that of the original's stroke color in order to produce a result that is visually identical.

Why would you want to perform such a conversion? Consider trying to make a line that looks a little more hand-drawn. SVG has no support for variable width strokes, but you can fake it by converting your stroke to a path and then tweaking the shape.




These days Inkscape can simulate variable width strokes using Live Path Effects, but that wasn't always the case. The LPE approach also supports varying the

thickness only symmetrically, whereas this manual approach lets you achieve effects such as thickening the stroke on one side of the center line whilst thinning it on the other.


Let's look at a more complicated example. This time we'll jump straight to a multisegment line with a dashed stroke applied. Once again the original line is at the top, and the bottom shows the effect of converting the stroke to a path.




Our converted line is starting to look a bit more interesting. Instead of a simple filled path, we now have a complex path, consisting of a number of filled sub-paths which match the visual appearance of the original line.

At first, this can be a little tricky to get your head around. Because

the resultant shape still looks the same, it's not obvious that it's actually now a filled path that has no stroke. Like any other path, you can actually add a stroke to it; here's the same result but with a thin, dashed, black stroke added to the converted line:



Hopefully it's now pretty clear what Stroke to Path does when presented with the simple case of an object with just a stroke applied. But what happens when your object is a bit more complex? Here's a line with a stroke applied, but also with markers at the start, end, and at each intermediate node.



What do you think should happen when Stroke to Path is applied to this object? To my mind there are three possible

alternatives:


- Remove the markers and convert the stroke as before.
- Convert the stroke, but also turn the markers into filled paths.
- Convert the stroke, but copy the markers to the new paths, so that each sub-path ends up with multiple markers.

Really old versions of Inkscape went with option 1. Stroke to Path converted the stroke to a path, and ignored everything else. But since version 0.44 (released in 2006), Inkscape uses the second option (no version uses the third option). This, however, is where not-sosubtle differences in behaviour for 1.0.x start to creep in.

Consider the shape above. Up to version 0.92 using Stroke to Path on this would have created a group containing five objects: the complex path generated by converting the stroke, and a separate path for each marker. In version 1.0.x the result is somewhat different. Now the output is a group containing two elements: the complex path, plus a nested group which contains four more deeply nested groups – one for each marker. Each of those marker groups contains two paths,

one each for the fill and the stroke of the marker. Yes, I said the stroke of the marker. I know you probably weren't even aware of markers having a separate stroke, but apparently they do and they're now converted into a path of their own.

If this sounds a little confusing, perhaps an image of the structure will help. On the left we have the Objects dialog from 0.92, and on the right we have one from 1.0.1 (excuse the different themes - the 1.0.1 snap is still broken with the standard theme, so I'm using the symbolic theme):




As you can see, the structures are substantially different. If you do want to convert a 1.0 arrangement to the old structure, it's quite simple: you just need to use Path > Union on each pair of marker paths (this is easier if you select them in the Objects dialog rather than on-canvas), then select the group that contains the

markers (i.e. not the top-level group, but the one just inside that), then repeatedly ungroup until you're left with a structure that looks like the one in the 0.92 dialog. Yes, "it's quite simple" was sarcasm.

For most users, this may never present a problem. The sort of usecase that requires you to add markers to your path does not generally intersect much with the use-cases for converting the stroke to a path. So, let's look at a far more common scenario: a path with both a stroke and a fill, but no markers. Here's what happens in 0.92.x, again with the original shapes at the top, and the Stroke to Path conversions at the bottom:



The obvious take-away from this is that 0.92 removes the fill entirely before the stroke is converted to a path. I've shown both closed and open shapes to make it clear that the behaviour is the same in both

cases. Structurally, you end up with a single filled path, just the same as you would if you'd performed the conversion on a shape with no fill or markers, the same as the first example I showed in this article.

Since version 1.0, however, performing a Stroke to Path operation on a shape with a fill results in a group that contains two filled paths: one is the usual path following the shape of the original stroke, whilst the other is a path representing the fill (i.e. it's just a copy of the original path, but without the stroke). The end result is visually identical to the original object.

As I'm sure you've guessed by now, performing a Stroke to Path on a shape with the holy trinity of stroke, fill and markers, results in a group containing:

- A path for the stroke
- A path for the fill
- A group containing an individual group for each marker, with each of those groups containing a path for the marker's stroke and a path for the marker's fill.

There are a few things to unpick from these changes. First of all, if you have an object with just a

stroke then the behaviour is the same as it has always been: you end up with a single filled path, which will have sub-paths if the stroke was dashed.

If your path has a stroke and a fill, however, you'll now end up with a group, rather than the fill being thrown away. This is particularly important to note if following an older tutorial. Many of them either rely on the fill being removed, or instruct you to duplicate the object before applying Stroke to Path so that you don't lose the fill. To get the same result as earlier versions, you can do one of two things:

- Remove the fill before using Stroke to Path.
- After using Stroke to Path, ungroup the result and delete the new path containing the fill (or just keep it, if you need it for subsequent steps).

Despite the confusion this change has caused with some new users, I generally think it's an improvement. Consider the case of drawing a simple cartoon character, with thick black outlines (strokes), and colored clothes and skin (fill). If you want to add some variety to the stroke thickness, the new

behaviour makes it easier to do so without having to duplicate every object, then remove its stroke, just to keep a copy of the filled shape.

Markers are another matter. however. While dealing with an unwanted fill just requires a couple of extra steps, getting the 0.92 structure when markers are in play requires several steps – multiplied by the number of markers – with no easy shortcuts. Although the new functionality may technically be more flexible, in practice there are few use-cases for separating the fill and stroke on a marker. It would have been nice to either have the old method available as a preference, or to include a function or extension that would make it easy to union deeply nested paths and recursively pop them out of their groups.

The take-away from all this is that Object to Path still behaves the same way it always did, Stroke to Path may need an extra step or two if you have a fill, but if you have markers as well then good luck to you!

Next time, I'll start to look at the changes to core drawing tools made with version 1.0.

### Krita To Rework Old Photos Pt.12

his series is aimed at learning to make something of the old photos in my possession, and others in the public domain due to their age. You, the reader, are welcome to tag along, and, I hope, glean some small insight and perhaps an idea or two from time to time. No promises are made as to quality of the content, or potential errors and omissions. I am a computer scientist, not a true artist or a professional of image restoration. So please take all this as a best effort, but with no firm guarantees — much as is the case of most open-source software.

In the previous part of this series, we worked on a technique that is often used in museum photo recreations, and consists of bringing out the main subjects of an image in color, while the background remains in black and white. In this final part of this series on using Krita to rework old photos, we will stay with early digital images and work on color density and enhancement.

Exhibit A for this article is a


photo I took in Hong Kong, just after the Olympic Games back in 2008. At that time, digital cameras were beginning to get better, and problems with lack of resolution were starting to be resolved (but can one really ever have sufficient resolution?). On the other hand, modern image enhancement techniques were absent, such as High Dynamic Range (HDR) in which several pictures of the same

scene are taken at varying exposure points, then combined to build a single photograph with more details both in the shade and in highly illuminated parts of the image. Other color enhancement schemes are now commonplace.


Some of these techniques would have been useful to me back in 2008. In this image, we get some interesting colors from the setting

sun (to our left, outside the field of view), but at the same time there are sharp shadows in which all detail has been lost. This is perhaps most noticeable in the buildings at the far left, whose facades are inshadow, and present a perhaps slightly ominous and not very attractive backdrop to the harbor.

The first thing to do, as usual, is take a look at the histogram.



It is interesting to note the contribution of different areas in the image to the overall pixel count. For instance, the clear blue sky and part of the water would seem to make up a large proportion of lighter pixels. However, the large blue pixel count seen to the right of the histogram actually denotes a lack of blue and

excess yellow in lighter colors of the histogram. On the other hand, there is a large amount of reddish pixels in the mid-tones in the histogram, that in fact correspond to an excess of blue in these shades. So, to correctly interpret this histogram, we need to think in terms of the water and sky actually being situated in the mid-tones of our histogram -- they are not actually the lightest pixels of our image. These would be, rather, the yellowish reflections of the chromed railing and the reddish


wall to the right of the image.


Finally, most dark pixels would seem to have some lack of blue to them, which is coherent with the darker shades of water and the buildings in the shade -- shadows often contain a slight tinge. However, there is a fairly lower amount of dark pixels, than light.

To correct these aspects and extend, as much as can be, the dynamic range of our image, it would be nice to accentuate the

gradient of colors in the lower part of the histogram, giving lighter shadows a tad more detail while retaining some darker shades as such. On the other hand, it may also be worth extending some midrange pixels up to lighter colors, though only for the red and green channels. The red channel already extends right up to the right-hand limit, and cannot be adjusted further. So, let us go into the menu option Filter, Adjust, and Color adjustment curves. Selecting the Lightness channel, let us move up a tad the lower curve section:

This takes care of the lower (darker) section of the histogram. Now, let's go back once more into Color adjustment curves, and now choose to modify only the Blue channel. When a single primary channel is selected in this tool, a specific histogram of this color is presented within the adjustment curve, and we can indeed see that there is a distinct lack of blue pixels in the lighter (right) part of the curve. Let us adjust this, by bringing the top right-hand extremity of the curve to the left, until it is above the right-most edge of the histogram edge. A similar

adjustment may be done to the left.

Do not worry if the image now has a slightly blue tinge to it - this is normal, since we have in essence increased the amount of blue light in the photo. Now, proceed in the same way for the green channel.


The end result is an image that now has a rather extended dynamic range, since we can see further details both in very light areas and within the shadows. This is especially visible in the darker areas underneath the railings, and in the facades of the leftmost buildings over the water: we can now actually see their rows of windows, instead of just an unformed mass of gray.

The effect is also rather different than that of the original image. We have gained some readability, but this has come at the expense of character. While our photo is now more nicely balanced as regards luminosity, its colors are more neutral -- and, perhaps, also a tad lackluster. To solve this

problem while retaining luminosity, let us augment the saturation of the image. We could go back once more to the adjustment curves, or even choose Filter > Adjust > HSV Adjustment, and increase the saturation of the whole image. But there is another option – that will allow us to increase the saturation of only some parts of the scene. In this case, I would like to leave most of the sea and sky as is, and increase the saturation of only the brown wall to the right and the reflections of the sun on the railing. Since these are pixels with rather more red to them than other channels, their saturation can be adjusted selectively by using the tool at the menu option Filter > Adjust > Cross-channel adjustment curves.

As the title suggests, this tool allows the adjustment of one channel or pixel characteristic, based upon another. We have already used them in part 9 of this series. In this case, however, we need to select pixels with a shade of red to them. This can be done using the Red channel as driver; however, if we do so, other pixels will get picked up. Even pure white



contains a large amount of red inside it, so the end result can easily get unexpected colorization. It is best to choose Hue as the driver channel. Specific hue values are not indicated on the curve, but one can experiment a little and observe that red hue is to the extreme left of the input range, then we move on successively to orange, yellow, green and violet as we proceed from left to right. In the capture below, we can see I used a number of control points to increase saturation for a certain range of hues centered about the

orange, but with a bit of margin towards pure red (left of our maximum) and yellow (right). I increased saturation values only by a very small amount. High ranges of saturation quickly degrade into a comic-like exaggeration of color. This is unfortunately common nowadays to some cameras' automatic color enhancement schemes, and even some professionally mastered videos. Even exercising care, I have purposefully let the saturation creep up to a slightly higher value than I would normally use, so it



The end result is a scene that looks brighter and has more engaging colors than the original image.

As previously stated, this will be the last part of this series on reworking old photos using Krita. As usual, the author himself has learned a lot while preparing the articles, and hopes that readers have also picked up a few useful tips and tricks. For the next few months, most articles will probably leave the more artistic realm and go back to techy stuff as usual, unless readers' ideas and suggestions come in for some particular use-case of our favorite operating system. Until then, take care!

## Music In Rhythmbox Pt.2

ast month, we talked about using Rhythmbox, the default application for 'ripping' CDs to MP3 format, to make your media easier to manage. This month, we'll talk more about exactly how to use Rhythmbox to manage your music collection.

Recapping from last month,
Rhythmbox will usually show up by
default on the Ubuntu Launcher,
close to the bottom of the default
applications that are there. Its icon
appears like a
rectangle with
some concentric
circles:

That's it, just above the 'Show Applications' drawer (the unmoving set of white squares at the bottom of the Favorites launcher).

Once you launch it by clicking the icon:



you'll see this screen (right).

As mentioned last month, when

you first run Rhythmbox, it automatically searches your hard drive and indexes all the existing music it finds.


#### TRACK PROPERTIES

As shown above, when you launch Rhythmbox, you will see a list of the music on your hard drive. You can right-click on any track and



select Properties to get access to

details on that track:



As you can see, there are fields you can edit that include the track name, the artist, the album name, genre, year of release, a comment field, and others, all on the default pane – Basic. Many of these properties will be filled in automatically if you are online when you rip the CD, and the album is found on the Musicbrainz online service that helps Rhythmbox to be more automated. At the top of the dialogue box, you can also switch to properties for the track's sorting parameters, details, and even album art.

#### **ALBUM ART**

The album art pane will default to showing the album art

downloaded automatically from the Musicbrainz service, assuming you were online when you ripped the MP3. If none shows up, you can click the Fetch button to try and retrieve it from Musicbrainz. If that doesn't work, you can find and download the art you choose, then click the Browse button on the Album Art pane and navigate to wherever you saved the art file.

## Additional Details – Track Ratings

The Details pane has additional properties for the track, the most interesting of which may well be Rating:




Under Rating, you can click however many stars you want to give the track, out of a possible five. Once you've done this, the track will show up in the default playlist 'My Top Rated' (on the left side of the program window), assuming you've given the track a four- or five-star rating:

The music in that playlist will automatically sort by higher-to-lower rated. Your 5 star tunes will be at the top, 4 star music at the bottom.



## Pardus Migration In Turkey

The open source software migration project of Eyüpsultan Municipality started in 2015.

All users were trained in GNU/ Pardus Linux and Libreoffice, and installed open source Libreoffice software instead of the licensed Office software on their computers. Therefore, the problems experienced in the migration of the operating system have been softened.

In parallel with this situation, there have been two major changes in IT infrastructure. One of these was the enterprise email system, ported to the open source Zimbra email server. Another is that our corporate governance application has started to use open source postgresql as a database.

In 2016, GNU / Pardus Linux and Libreoffice training was repeated and GNU/Pardus Linux was installed on the computers of those who passed the exam at the end of the training.

Thus, the migration of the operating system began. Those who fail the exam are re-educated, then GNU / Pardus Linux operating systems were installed and continued to operate.

As it has been noticed, necessary training has been

provided throughout the open source migration project and they have been checked to see if the training produced the necessary effect.

My personal opinion is that, for the open source migration project in Eyüpsultan Municipality, the main reason for its success is regular training.

As Eyüpsultan municipality, we have always cared about this issue and we have prevented it from being overlooked or forgotten by taking part in the project plan.



#### **MY STORY**

I want to briefly talk about the Project steps:

- Analysis
- Planning
- ISO
- Test
- Pilot
- Production

The steps I mentioned will be familiar to many people. I want to draw attention to the two points that made this project successful in Eyüpsultan Municipality.

One of these is the analysis step.

We didn't just do technical analysis at this step, we did psychological analysis at the same time. So, by talking to people, we actually tried to find out their anxiety points. Our conclusion was the fear of an "encounter with the unknown". Therefore, if you are unable to calm this fear, the rate of resistance to change will rise, even if you have management support behind you.

After we realized this, we started to discuss how we could overcome this situation, and the result of this discussion was to put an interface in front of the user

that he would recognize. With our research, we found a Windows theme and turned it into the default window manager of the GNU/Pardus Linux operating system.

The reaction we got on the first day of training was amazing, which I still smile when I think about it.

The second step I'm going to talk about is ISO; ISO means the creation of an image file.

Yes, the GNU / Pardus Linux operating system has an ISO that you can download and install, but there are many applications that you will not need in that image file. When the installation is finished, removing unnecessary applications and installing your own enterprise applications will be a waste of time.

To compensate for this loss of time, we have reconfigured the GNU/Pardus Linux ISO to include our own enterprise applications. This reduced the installation time to 15 minutes, and by the end of the installation, enterprise applications were ready for use.

Once the project matured,

management and monitoring requirements occurred.

We installed the Lider/Ahenk server to manage GNU/Pardus Linux clients. To monitor servers and clients, we installed the open source Zabbix application.

So we tried to ensure that the migration project was manageable and sustainable. At this point, hundreds of pardus clients can be updated from a single point, remote support can be given and policies can be implemented, and problems can be detected early with alarms from Zabbix, and precautions taken.

As Eyüpsultan municipality, we consider this project as a social responsibility project. We are trying to create awareness by pioneering the use of the GNU/ Pardus Linux operating system in public institutions in Turkey.

I am proud to be a part of such a project.

### **Ubuntu 20.10**

B ecause of the way the Ubuntu development cycle works, there is often a lot of interest in the first "standard" release that follows a Long Term Support (LTS) release.

In many cases, the development priorities and new features intended for the next LTS version will be introduced in the first release of the new cycle, to be followed by two more standard releases to refine them before the next LTS comes out. With Ubuntu 20.04 LTS released in April, 2020, the version that starts this new development cycle is Ubuntu 20.10, which came out on 22 October, 2020. This release is the first step towards Ubuntu 22.04, the next LTS, due out in April, 2022.

Being a standard release, Ubuntu 20.10 has only nine months of support, until July 2021.

#### **S**YSTEM REQUIREMENTS

The recommended minimum system requirements for Ubuntu

20.10 have not changed since 20.04 LTS and remain:

- 2 GHz dual core processor
- 4 GiB RAM
- 25 GB of hard-drive, USB stick, memory card or external drive space
- Screen capable of 1024x768 pixel screen resolution
- Either a CD/DVD drive or a USB port for the installation media
- Internet access is useful, but not essential

I tested Ubuntu 20.10 on a 2011 vintage System 76 Pangolin

Performance laptop, with 4 GiB of RAM and dual core/four thread 2.30GHz Intel Core i5-2410M CPUs, which is pretty close to the minimum hardware.

#### **BOOTING IT UP**

I downloaded Ubuntu 20.10 from the Ubuntu website via bit torrent, did the SHA256 sum check to ensure the download was good and made up a USB installer using the Ubuntu Startup Disk Creator.

I booted to Ubuntu 20.10 in live


sessions, a process that starts with an automatic file system check. The check is worth letting run to make sure you have a flawless USB and that Ubuntu will run right.

Once Ubuntu 20.10 is booted up, it shows the default dark purple desktop wallpaper, with, yes, a gorilla wearing sunglasses. If this wallpaper proves a bit too predictable then there are six other new wallpapers included, including a grey gorilla, plus some nice alternative artwork. If none of those are appealing, then using your own personal favorite wallpaper is easy, too.

#### WHAT'S NEW

Other than the new gorilla wallpaper, this version of Ubuntu does not introduce many new user interface changes. It instead focuses on updating the hardware support, through a new version of the Linux kernel, version 5.8.

Linux 5.8 includes support for USB 4 (Thunderbolt 3), AMD Zen 3



CPUs, Intel Ice Lake and Tiger Lake graphics, plus initial-level support for POWER10 processors. There are also desktop images that support the Raspberry Pi 4, in both 4 GB and 8 GB versions.

Ubuntu 20.10 includes the Gnome 3.38 desktop, which features an enhanced Activities Overview, some small menu tweaks and provides overall better performance over earlier Gnome versions. This version of Gnome also brings improvements to the applications grid (main applications menu), which replaces the two "all" and "frequent" application menus with a single menu that allows more customization, including manually rearranging or even

stacking icons, so they don't have to be just in alphabetical order. Frequently used applications can be placed at the top of the menu, for instance, to make them quicker to find. Application folders can also be created and managed. Overall, these changes are a welcome improvement.

Most of the core applications included with the ISO have been updated and there is also a new firewall backend, as nftables replaces iptables. Support for fingerprint login has also been improved.

Ubuntu 20.10 includes updated developer tools too including glibc 2.32, OpenJDK 11, rustc 1.41, GCC

10, LLVM 11, Python 3.8.6, ruby 2.7.0, php 7.4.9, perl 5.30 and golang 1.13. It is worth noting that the ZFS file system option is no long marked "experimental" in Ubuntu 20.10.


What is probably most notable here is that none of these changes are ones that the average Ubuntu desktop user will notice.


#### **APPLICATIONS**

The Gnome 3.38 desktop includes many updated applications, including the Cheese 3.38 webcam application, Document Viewer (Evince) 3.38.0 PDF viewer, Files (Nautilus) 3.38.1

file manager, Gnome Calendar 3.38.1 desktop calendar, Gnome Disks 3.38.0 disk manager, Gnome Terminal 3.38.0 terminal emulator, Image Viewer (Eye of Gnome) 3.38.0 image viewer, Text Editor (gedit) 3.38.0 text editor, Ubuntu Software (Gnome Software) 3.38.0 package management system and the Videos (Totem) 3.38.0 movie player.

There are a couple of non-Gnome 3.38 applications, which are holdovers from earlier Gnome versions: Document Scanner (Simple Scan) 3.36.4 optical scanner, Rhythmbox 3.4.4 music player and the Shotwell 0.30.10 photo manager.







Rounding out the suite of default applications from various sources are the CUPS 2.3.3 printing system, Firefox 82.0 web browser, Gparted 1.0.0 partition editor, LibreOffice 7.0.2 office suite, PulseAudio 13.99.2 audio controller, Remmina 1.4.8 remote desktop client, Startup Disk Creator 0.3.8 (usb-creator-gtk) USB ISO writer, Thunderbird 78.3.2 email client and the Transmission 3.00 bit torrent client.

Notably not included by default are a CD/DVD burning application or a video editor. CDs and DVDs are considered pretty much obsolete in 2020. Laptops and desktop computers have not come with optical drives for many years, but if you still have one and some CDs or DVDs to burn, then Gnome's Brasero can always be installed. Alternatives include KDE's K3B, or even Xfburn from Xfce, which are all in the repositories. Likewise if you do create videos, there are a number of good video editors that can quickly be installed.

Text Editor (Gedit) 3.38.0 is the text editor included in Ubuntu 20.10 and it is useful for coding, as well as creating text documents. It offers seven syntax highlighting

color schemes, including three that are the currently-obligatory dark schemes. As with past versions, Gedit has out-of-the-box spellchecking (Shift+F7), which is a very useful feature in a text editor.

Files (Nautilus) 3.38.1 is probably the weakest point in Ubuntu 20.10. Ever since it went through an interface simplification with version 3.6 in 2012, Nautilus has really lacked basic functionality as a file manager, like an "up one level" button. Many Linux distributions were unhappy with Nautilus after that simplification and have replaced it with better file managers, like Linux Mint's Nemo fork of Nautilus, Nemo restores all the needed features

that Nautilus removed and is a good choice to install in place of Nautilus. Again, it is in the Ubuntu repositories and integrates well with the Gnome desktop.

Ubuntu 20.20 features the LibreOffice 7.0.2 suite and includes all the LibreOffice components, except the LibreOffice Math mathematics formula writer and LibreOffice Base database application. These are the leastused applications in the office suit and can be installed, if needed.

#### **S**ETTINGS AND THEMES

controlled from the Settings menu,

The system settings are

which may be the best control system in any Linux distribution today. It puts all the user settings in one place, in logical order and enables you to quickly customize Ubuntu to meet your needs. If Nautilus is an Ubuntu low point, then the Settings menu is a high point.

Ubuntu's implementation of the Gnome desktop is highly modified from the stock Gnome Shell, to make it look and work a lot like the old Unity interface. This includes the application launcher bar, which is normally always visible, but which can be set to hide when an application window touches it. By default the launcher is on the left side of the screen, but can be moved to the right side or the bottom to make it look more "Maclike". It cannot be set to the top, however, as it would interfere with menus there. The launcher icon size can easily be changed too, to make it a better fit for screen size, as well as touch screen or mouse use.

Ubuntu 20.10 offers the same window themes as 20.04 LTS did, three choices: light, standard and dark. Even though dark themes are currently very popular, both the dark and standard themes have

poor active/inactive window differentiation. The light theme is more effective, rendering active window tops a medium grey and inactive ones a much lighter grey.

#### **TESTING**

In use, Ubuntu 20.10 is fast and smooth, operating without any hesitation, even with the minimum 4 GiB of RAM recommended. Ubuntu 20.10 shows that it hasn't lost any of the speed that was introduced in Ubuntu 19.10. That release, a year ago, brought a significant improvement in speed that makes Ubuntu feel much lighter and faster. Those improvements are still with us in 20.10.

#### **CONCLUSIONS**

While Ubuntu 20.10 is a really solid release, it has surprisingly few new features for a release that initiates a new Ubuntu development cycle. In many ways this is probably a good sign, though. After 33 releases over 16 years, Ubuntu a very mature Linux distribution and it gets almost everything right. There is not really a lot that needs changing, beyond


updating the hardware support for the next generation of computers and also updating the default applications, both of which this release does.

These days most Ubuntu users run the current LTS release and only upgrade when a new LTS version comes out. This standard release offers very little to entice most Ubuntu users to switch, especially since it has only nine

months of support. Most Ubuntu users will probably treat it as an early developmental release for the next LTS and stick with 20.04 LTS until the next LTS comes out in April 2022.

### Task Warrior

have been using Ubuntu as my main at-home OS for approximately 10 years. One of the things I like most about Linux is that I can freely modify, customize, and break the OS without breaking any laws or Terms of Service clauses. Additionally, I am a huge fan of the way so many applications in Linux do one thing really, really well.

This brings me to my review of Task Warrior – the Linux command-line To-Do List. I first took a look at Task Warrior several years ago. It is very lightweight and blazing fast – the best thing, from my perspective, is that it runs in the terminal. Task Warrior is in the Ubuntu repository so installation is simple.

To run Task Warrior, simply open the terminal and type task add followed by the text of the task you want to add. The very first time you run Task Warrior, it will ask you if you want to add a generic .taskrc file to your home directory.

Once you say yes, you will be

ready to go.

The basic syntax for adding a task is:

task add <task description>
project:<project name>
due:<due date><T due time>
priority:<H,M,L>


For example, to add a task with the description "Write Task Warrior Review" for the project "Linux" with the due date "tomorrow" at "3:00 pm", and the priority M, you would type: task add Write Task Warrior
Review project:Linux
due:tomT15:00 priority:M

Tasks may be sorted by project, status, due date, priority, or almost any other tag you care to assign to a task.

Task Warrior comes with many predefined reports, but the one I use most often is invoked with the command task list (see image below).

have used many different To-Do lists and calendar programs over the years, and, after trying many different options, I found myself wishing that Task Warrior were easier to use on multiple machines.

In a nutshell, if you want to sync your tasks to another device you need to have access to a Task Server. Recently I stumbled across one such task server called FreeCinc (https://freecinc.com/). Jack Desert, the guy who created





FreeCinc is just a really cool Linux guy who allows anyone to generate keys for his server free of change. Once you click "Generate Keys", you are taken to a page from which you can download three files. You are also given all of the code you need to run in the terminal in order to get your version of Task Warrior to sync with his server.

The three files you will need are the key.pem, cert.pem, and ca.pem files. I would save these files to a location such as Google Drive so you can access them on a mobile device. I recommend that you also save a PDF of the web page with the necessary code so that you can set up Task Warrior using the same account on another machine.

In my case, it is really important to me that I can access my tasks on my Android phone. Thankfully there is a free application in the Google Play Store called Foreground which lets you sync with a task server.

Once you install Foreground on your phone, you need to configure it to read and write to the account on Jack's FreeCinc server. This is where saving the three files we downloaded earlier to Google

Drive comes in. In the configuration options, there are three folders you can press and search to load the appropriate files. Aside from the three files we downloaded and saved to Google Drive, you will need to type in the name of the server – FreeCinc.

Once this has been done, you should be able to sync tasks from your computer to your phone and from your phone to your computer.

Total setup time on the computer, the task server, and the phone took less than 30 minutes.

#### **SPEECH TO TEXT**

While translating the Q&A column of FCM#161 (for the French version of the magazine), I read with interest that there are two speech-to-text applications for Ubuntu; Simon (from KDE) and Deep Speech (from Mozilla). After a bit of searching on the KDE site, I came across a download button for the beta of Simon. I was also able to watch a bit of the training video. When I followed the link to Deep Speech, all I got was a page full of code. Because of this, it seems logical for me to conclude that neither is 100% usable, except for people with advanced knowledge of Linux.

That being said, how can Android provide speech-to-text with almost no problem at all? Once you have realized you need to speak naturally, rather than dictate your text. The training was apparently by doing. As with even written texts, where the automatic corrections can be catastrophic, you must, of course, go over the message/letter before sending it,

to put in periods and capitals where necessary and to correct the (relatively few) misunderstandings.

Is there any way to use Android's speech-to-text capacities in Ubuntu?

Perhaps I should have sent this email to Erik for the Q. and A. column, but you rarely receive letters, so I decided to do it this way.

A: I am not going to comment. You can try rEFInd. <a href="https://www.rodsbooks.com/refind">https://www.rodsbooks.com/refind</a> Q: I want to replace my HDD with an SDD because it is slow. I don't want to lose my data and I don't want to reinstall. This is a laptop, so I don't want to have to buy an external caddy. I have a ASUS X543 with ubuntu 18. Thanks for the help.

A: I have bad news for you. A SSD will only increase your boot speed. I looked up the laptop and the bottleneck is the CPU. You can try maxing out that thing's memory and disable the swap file, as entry level laptops usually cannot take much memory and a swap file will kill a SSD slowly. As for your question, if you do not want a caddy, you can get a second drive bay that sits in the CDROM's place. You can also clone your drive to a big USB thumb drive or even clone it over the network.

Q: At the recommendation of the GNU group, I installed MuPDF, but I don't see any controls. What did I do wrong?



: MuPDF does not have any; **A**you use your keyboard and mouse. That is how SumatraPDF was born, built on MuPDF.

: Hey. I am new to Ubuntu and wanted to know if Ubuntu can do snipping tool?

: This question is not as simple as it seems, you see there are many screenshot tools, but none come with built-in annotation & drawing. Those that do, like Flameshot, are not simple and easy to use. : Thanks for your previous help, I was following instructions to set up a backup for my Ubuntu server. It says create a "backup drive". How do I create one?

: There are no special A instructions, just format a drive with your chosen file system and set your backup to point to your drive, wherever it may be.

: Nadir, [28.08.20 00:17] [In reply to EriktheUnready] I want to use my Raspberry Pi 2GB as a media centre for my TV. Since it is only 2GB, what desktop Environment do you suggest I use? It is just for movies and series.

 $\Lambda$ : I suggest you do not use any. But if you really want a DE, I suggest Raspbian and Kodi. But otherwise I would suggest OSMC. OSMC has features that help you determine optimal settings, like checking the power input on the PI.

: ubaid0, [23.08.20 20:50] If you  $\prec$  don't want to answer, it is OK, but how do I defeat Mac address banning with macchanger to be automatic? Go to the setting.

↑ : Macchanger is great, but did H you know your stock standard network connection setting has an option to randomize your mac address every time you connect? Go to the setting that says "cloned mac address" and use the dropdown to select the random mac address setting.

: Whenever I try to open a .flac file in Clementine on Ubuntu

18.04, it adds it to the bottom of my playlist and plays the next song. I am pulling my hair out with frustration.

: Buddy, you need: https:// **H**www.strawberrymusicplayer.or g/ from what I can tell, it seems some formats, like FLAC, are not supported by default on Clementine. For Audiophiles, like yourself, Clementine was forked into Strawberry music player.

: TobyA88, [12.09.20 06:55] [In  $\prec$  reply to EriktheUnready 1You said I can use geany for python development, but when I press F5, I get an error on a simple input command. Why is that?

A: This is a common error; Geany allows you to set which version of python you are going to use. By default, it will call the 'python' command, which equates to Python2. You need to go to 'build' -> 'set build commands' and just edit python to python3 under 'compile' and under 'execute'.

: Can you help me? I made a mistake with a PPA. I am not good at the command line. Now when I try to update, I get an error. I don't know how to fix it. I am on Xubuntu 18.

A: Easiest way for you is to add synaptic package manager with "sudo apt install synaptic", then open synaptic and go to settings -> repositories -> other software. Find the faulty PPA and un-tick the entry. If you cannot, you can look for "software and updates" in the menu, and do the same. (I am not sure if this is in all the flavours of Ubuntu, but it is



worth a try first as it does not require any installation).

Q: On Xubuntu, how do I change my mouse themes to previously installed themes, without going through the whole process again? I kinda feel the long way defeats the process, don't you? Aslo how can I edit them for other colours?

A: You lost me with 'whole process', you can simply open your start menu, type mouse, and open the "mouse and touchpad" settings, the third tab is "Themes". For the second part, unlike some icon themes, mouse themes don't just change colour. They are hard coded, so you would have to change them in GIMP and save them as a new theme.

Q: My wifi on my new AMD PC disconnects by itself. Unlike my previous PC, it has a built-in wifi card and Antenna. So I cannot remove it and put another in its place. What do I do?

A: First I would suggest seeing why it disconnects; there is a log, open up a terminal and type:

sudo journalctl -b 0 -u
NetworkManager - Page through
the log and see if you are any wiser.
As to the hardware aspect, you can
disable the on-board WiFi and use a
USB wifi that supports Linux well to
test. (I think TP link has cheap ones
that are certified Linux
compatible).

Q: I received the notification that I can upgrade my Ubuntu 18.04 to Ubuntu 20.04. When I try, I get an error: E: The repository 'http://ppa.launchpad.net/xxxxxx/ppa/ubuntu bionic Release' does not have a Release file on two of my entries, and now I am stuck. I tried asking the question elsewhere, but I get "marked as duplicate" instead of an answer. It is so frustrating.

A: \*Marked as duplicate. - Just kidding. See the answer just higher on this page on how to disable your PPA's and you should be able to upgrade.

Q: What is the easiest way to make my newly installed Ubuntu 20.04 look like my iMac? The tutorial I used previously does not work on Ubuntu 20.04 any more.

A: There are many resources, Noobslabs, Ubuntu Pit, etc, all have step-by-step instructions to do this. I just checked Youtube and they are there too, so I won't go into it here. All of them are simple and straightforward. Forget about the old site and take a brave new step.

Q: What is the easiest way to make space? I have run out. My SSD is tiny and I want to make space safely. I am still on Ubuntu 18.04 on my HP probook with 4GB of memory.

A: Stacer. Run Stacer on Ubuntu and select the cleaning option. Then select all the categories and click on the broom icon to clean. Once you have space, I suggest zipping some of your stuff. What Stacer does not clean is social apps like Telegram, you will have to enter the directory manually and delete all those pictures it downloads.

Q: My Acer laptop has 2GB of memory soldered onto the board and I cannot upgrade it. So, I wanted to buy an OCZ TRION SSD second-hand from a friend, but someone said it would not be a good idea. Won't a SSD make the computer faster?

↑ : Yes, and a SSD will. I suspect H the reasoning behind the warning has to do with your amount of memory. When you have little memory, Ubuntu swaps in and out of a file or partition. However, since this file or partition has to be stationary, it cannot be moved about on the SDD to mitigate wear and tear. It is like chafing an area on a carpet, for instance. If you chafe randomly, the wear is even, but you can burn through one spot very quickly. Generally SSDs have a longer lifespan than a hard drive, but they are very weak if you chafe one spot continuously.

Blurb: "Stalk and consume those that imprisoned you to spread fear and panic throughout the facility. Grow and evolve as you tear down this prison and acquire more and more devastating abilities on the path to retribution."

'arrion is a monster simulator with a bit of "metroid-vania". You sneak around an underground laboratory, murdering everyone in sight. If ever you had one of those rubber octopus toys that you soaped up and threw against the wall, just to watch it climb down, you had an awesome childhood. Your character feels like that, but with more chaotic tentacles. Moving around the screen can almost feel satisfying in itself. The movement feels effortless and almost "floaty". You need to feed to grow, and damage will make you shrink. Eating pesky humans is the way you do it. Size has another perk. You gain new abilities that are tied to your current size. Killing humans is not the only thing happening on-screen. You have puzzles to solve as well. These puzzles require specific abilities to solve, which in turn is tied to size,

which make the puzzles clever.

Size isn't everything (that's what she said!); you can not just grow and steamroller everything. The enemies are varied, so that a 'mechs' or flame-thrower wielding soldiers can whittle you down in seconds. You need to use the

terrain to ambush your prey. The level design helps you a lot, and is usually designed so that you have the freedom to tackle a problem from any angle. If you misjudge a situation, there are numerous ways to hide and flee. I would say that sometimes you need to be creative, but it is actually encouraged all the

time. You do not need to "think outside the box" – the game just wants you to rub your hands with glee once you have pulled off a very sneaky, underhanded manoeuvre. This is where a lot of the enjoyment in the game lies. Some of the not-so-satisfying moments are when there is a lot happening on-screen, and you have your own tentacles swishing this way and that. You just do not know which of your tentacles you are

controlling. The other is when you play a human. Not sure where that fits in.

The graphics are ok, the rag-doll physics are ok-ish. Somehow it does not matter that much as I found myself looking at all the flailing tentacles and dripping blood. The sound fits this game like a glove; the screams sound like screams, and ripping doors or skylights apart makes just that sound. Crunching

bones and clanging metal make the sounds they should, and will deepen your immersion into the game.

For a reverse horror game, I found enjoyment that I did not think I would. I almost burnt my supper trying it out. I think you should try it out too.


